EFFECT OF CREDIT RISK MANAGEMENT ON FINANCIAL STABILITY OF QOUTED DEPOSIT MONEY BANKS (DMBs) IN NIGERIA

Abstract

Financial stability remains a critical concern for banking systems, particularly in emerging economies where macroeconomic volatility and sectoral credit concentration increase default risk. This study examined the effect of credit risk management on the financial stability of listed deposit money banks over the study period using panel data analysis. Secondary data were obtained from published annual reports of selected banks, covering 130 firm-year observations. The findings revealed that non-performing loans have a negative and statistically significant effect on financial stability, indicating that deterioration in asset quality weakens bank resilience. Capital adequacy ratio was found to have a positive and significant effect on financial stability, suggesting that well-capitalized banks are better positioned to absorb shocks and maintain operational continuity. However, loan loss provisions showed a negative but statistically insignificant relationship with financial stability. The study concludes that effective credit risk management, particularly in controlling non-performing loans and maintaining adequate capital buffers, is essential for sustaining financial stability. It recommends strengthened credit monitoring, enhanced risk assessment frameworks, and continuous regulatory supervision to ensure resilience in the banking sector.

Introduction

Financial stability is a fundamental objective of modern financial systems across the world because it supports sustainable economic growth, maintains investor confidence, and prevents systemic banking crises. Globally, banking regulators and international financial institutions emphasize that financial stability depends largely on the quality of risk management, particularly credit risk control. Credit risk, which represents the possibility that borrowers will default on loan obligations, remains one of the most significant threats to banking systems worldwide. Historical financial crises have demonstrated that excessive credit exposure, weak underwriting standards, and poor provisioning practices can trigger systemic instability. The International Monetary Fund reported that global financial stability is currently challenged by rising inflationary pressures, tightening monetary conditions, and debt vulnerabilities in emerging economies, with non-performing loan ratios projected to rise in several jurisdictions.

Similarly, the Basel Committee on Banking Supervision continues to advocate strong capital buffers, effective risk governance, and prudent lending standards as essential safeguards against banking distress (IMF, 2024; BCBS, 2021).

In Nigeria, the banking sector plays a critical role in economic development by mobilizing savings, facilitating investment, and supporting business activities. Deposit money banks are particularly important because of their systemic influence on financial intermediation, monetary transmission, and economic growth. Over the years, the Nigerian banking industry has experienced recurring episodes of financial distress linked to poor credit risk management and rising non-performing loans (NPLs). Following the 2009 banking crisis, the industry NPL ratio exceeded 30%, leading to regulatory interventions and banking sector reforms aimed at strengthening asset quality and capital adequacy (Sanusi, 2010). Between 2016 and 2018, the NPL ratio again rose above the prudential threshold of 5%, largely due to the economic recession and the banking sector's heavy exposure to the oil and gas sector (CBN, 2018). However, subsequent regulatory measures and improved risk management practices contributed to gradual declines in NPL levels in later years.

Despite these reforms led by the Central Bank of Nigeria, credit risk remains a major challenge facing the Nigerian banking industry. The industry NPL ratio declined to about 6.0% in 2019, 5.7% in 2020, and further to approximately 4.2% in 2024, remaining below the prudential benchmark of 5%, thereby indicating moderate improvement in asset quality (CBN, 2024). Nevertheless, substantial disparities persist among banks, particularly those with significant exposure to high-risk sectors such as oil and gas, manufacturing, agriculture, and trade (Ugoani, 2021; Adeleke & Yusuf, 2023). In addition, macroeconomic conditions have continued to exert pressure on banking operations. Rising inflation, exchange rate depreciation, and monetary tightening significantly increased credit default risks between 2022 and 2024. Inflation exceeded 28% in 2023 and rose above 30% in 2024, thereby weakening borrowers' repayment capacity and increasing financial vulnerability within the banking sector (IMF, 2024).

Furthermore, global economic uncertainties, geopolitical tensions, and interest rate volatility have intensified financial sector risks in emerging economies, including Nigeria. Financial market forecasts suggest that adverse macroeconomic conditions could push future NPL ratios toward 6–7% if banks fail to strengthen credit risk monitoring and provisioning frameworks

(S&P Global, 2025). These developments underscore the sensitivity of Nigeria's banking system to both domestic and international economic shocks and reinforce the importance of effective credit risk management in sustaining the financial stability of deposit money banks.

For listed deposit money banks, effective credit risk management is essential for maintaining financial stability and protecting shareholder and depositor interests. Listed banks on the Nigerian Exchange Group are particularly significant because of their systemic importance and market visibility. Previous studies have mainly focused on single indicators such as NPL ratios or profitability measures, but contemporary risk governance requires multidimensional credit risk management approaches covering underwriting quality, loan monitoring, provisioning adequacy, and concentration risk control (Musa & Ajibola, 2021; Ene & Bello, 2019). Furthermore, macroeconomic shocks and regulatory policy changes influence banking outcomes, necessitating comprehensive empirical investigation of credit risk management practices and financial stability. Understanding how credit risk indicators such as non-performing loans, loan loss provisions, and capital adequacy ratios affect the stability of listed deposit money banks is therefore important for regulators, bank management, and investors seeking to strengthen the resilience of Nigeria's banking system (Ugoani, 2021; Adeleke & Yusuf, 2023). Therefore, this study examined credit risk management practices influence the financial stability of listed deposit money banks in Nigeria.

Hypotheses

The study hypotheses are stated in Null form in line with the objectives of the study.

H₀₁: Non-performing loans have no significant effect on the financial stability of listed banks in Nigeria.

H₀₂: Loan loss provision has no significant effect on the financial stability of listed banks in Nigeria.

H₀₃: Capital adequacy ratio has no significant effect on the financial stability of listed banks in Nigeria.



Literature Review

Concept of Financial Stability

Financial stability is considered as the ability to facilitate and enhance economic processes, manage risks, and absorb shocks (Job, et al., 2018). Financial stability has also been argued in multiple ways by scholars, reflecting its multidimensional nature as both a systemic condition and an institutional outcome. The International Monetary Fund (IMF, 2024) described financial stability as a state in which a country's financial system comprising institutions, markets, and infrastructure is capable of withstanding shocks and stresses while continuing to allocate resources efficiently, facilitate payments, and support sustainable economic activity. Mishkin (2011) conceptualizes financial stability in terms of the smooth functioning of financial markets and institutions, such that the intermediation process (transforming savings into investment) operates without interruption even under adverse conditions.

Beck et al. (2006) extend this view by arguing that financial stability encompasses both the prevention of bank failures and the mitigation of systemic risk, where distress in one institution or market segment can propagate through the entire financial system. Common measures include the Z-score which combines return on assets, equity, and earnings volatility to estimate insolvency risk capital adequacy ratios, liquidity coverage ratios, and non-performing loan ratios (IMF, 2024; Nkusu, 2011).

Concept of Credit Risk Management

Credit risk management in financial institutions has become crucial for the survival and growth of these institutions. It is a structured approach of uncertainty management through risk assessment, development of strategies to manage it and mitigation of risk using managerial resources (Afriyie & Akotey, 2011). Credit Risk Management (CRM) refers to the processes, strategies, and frameworks that financial institutions adopt to identify, assess, monitor, and mitigate the risk of losses arising from borrower defaults. The Central Bank of Nigeria (CBN, 2024) emphasizes that effective credit risk management requires banks to implement robust credit appraisal systems, maintain adequate loan loss provisions (LLPs), and ensure capital buffers aligned with the risk profile of their lending portfolios. Empirical studies demonstrated the practical impact of CRM on financial stability.



Credit risk cannot be totally avoided as it impacts the fundamental activities of banks which is the loans availed to customers and banks are formulating credit policies to manage risk to improve asset quality through borrowers guarantees and collateral request (Al Zaidanin & Al Zaidanin, 2021). Credit risk management refers to the strategies and practices banks use to reduce the likelihood of loan defaults and minimize losses (Gana et al., 2022). This involves assessing borrowers' creditworthiness, setting loan conditions, monitoring loan repayments, and making provisions for possible loan losses (Fadun & Silwimba, 2023).

Empirical Review

Non-Performing Loans and Financial Stability

Pradhan (2024) studied the relationship between NPLs and financial stability in commercial banks in Nepal and found that high NPL ratios constrain new lending, indirectly affecting long-term bank stability. This illustrates a feedback loop where credit risk suppresses growth and stability. However, the study did not consider loan-loss provisions or moderating variables such as board expertise, limiting its applicability to institutions with proactive risk management. The methodology relied on static regression models, which do not capture time-lagged effects of NPLs on stability. Additionally, cross-country context reduces direct comparability to Nigerian banks. While the findings highlight the risks of elevated NPLs, they underrepresent the effectiveness of managerial and regulatory interventions. The study period was limited to five years, restricting the analysis of long-term trends. Therefore, there is a need for context-specific studies that incorporate dynamic risk-mitigation factors.

Adeleke (2023) analyzed the interaction between NPLs, loan-loss provisions, and bank stability using panel regression on Nigerian listed banks and found that NPLs negatively affect earnings, but provisioning partially mitigates this effect. The results revealed that the impact of NPLs unfolds over multiple reporting periods, emphasizing the importance of timing in risk recognition. However, the study was sensitive to model specification, suggesting possible endogeneity that could bias results. The research did not explore the moderating role of risk committee expertise, leaving a critical governance dimension unexamined. The analysis covered only listed banks, limiting generalizability to smaller or microfinance banks. While providing valuable insights into the dynamic effect of NPLs, the study underestimates the



broader influence of governance and managerial oversight. Additionally, the study period excluded very recent economic shocks, potentially affecting contemporary relevance.

Loan Loss Provision (LLP) Financial Stability

Kasie, et al. (2023) analyzed the relationship between LLPs and various measures of financial stability in Nigerian deposit money banks, including ROA, ROE, and NIM. Their study revealed that while LLPs reduce stability in the short term, they enhance financial resilience by mitigating the impact of loan defaults on capital buffers. However, the research used ordinary least squares regression, which may not fully account for the dynamic interplay between LLPs and stability over time. The study also excluded moderating governance factors such as risk committee expertise, limiting insights into how strategic oversight affects provisioning effectiveness. Additionally, sectoral loan composition was not examined, potentially overlooking differences in risk exposure. Despite these limitations, the study contributes valuable evidence on the long-term stabilizing role of LLPs.

Owolabi and Ajayi (2021) investigated LLPs' impact on financial stability in Nigerian commercial banks, highlighting that banks with effective provisioning policies maintain more stable ROA and ROE during credit risk shocks. However, the study did not include risk committee expertise or other moderating factors, leaving a gap in understanding how governance can optimize provisioning strategies. The research focused on listed banks, limiting generalizability to smaller financial institutions or microfinance banks. Additionally, the study did not examine the interaction between LLPs and capital adequacy, which could provide insights into integrated risk management practices. Despite these limitations, the study reinforces the protective function of LLPs against financial instability.

Eze and Ogbonna (2020) examined the effect of LLPs on the financial stability of Nigerian commercial banks, finding that proactive provisioning reduces the volatility of bank earnings and mitigates systemic risk. The study highlighted that banks with structured provisioning frameworks were better positioned to withstand credit shocks. However, the research did not account for the moderating role of risk committee expertise, which could enhance the effectiveness of LLP policies. The period covered (2013–2018) may not capture recent regulatory changes affecting provisioning practices. Additionally, the study relied primarily on ROA and ROE, potentially ignoring other stability indicators like Z-score or NPL ratios. While

the findings affirm the stabilizing function of LLPs, they leave gaps in understanding governance influence and long-term sustainability.

Capital Adequacy Ratio and Financial Stability

Folarin and Adebayo (2021) analyzed CAR and financial resilience in Nigerian commercial banks, showing that banks with higher CAR experienced lower volatility in earnings and stronger solvency positions. The study, however, overlooked the governance dimension, particularly risk committee expertise, which may determine the strategic deployment of capital buffers. Loan portfolio heterogeneity was not considered, potentially masking how CAR's effectiveness varies by credit composition. The study period also excluded recent economic shocks such as the COVID-19 pandemic, which could influence CAR-stability dynamics. Despite these limitations, the findings underscore CAR as a key factor in mitigating financial risk.

Adeleke (2023) examined the impact of CAR on the stability of Nigerian commercial banks using panel regression models. The study found that higher CAR strengthens banks' resilience to shocks and reduces the likelihood of insolvency, highlighting CAR as a critical buffer against credit and liquidity risks. However, the research did not consider the moderating role of risk committee expertise, which may enhance the strategic allocation of capital and improve stability outcomes. The study focused on traditional accounting measures such as ROA and ROE, neglecting market-based indicators like Z-score. Additionally, CAR thresholds were not disaggregated by bank size, which could provide more nuanced insights. While the study confirms the stabilizing role of CAR, it leaves gaps in governance and methodological detail.

Balogun and Adebayo (2020) explored CAR and financial stability in Nigerian deposit money banks, showing that banks maintaining CAR above regulatory minimums were better able to absorb shocks from loan defaults and liquidity stress. The study omitted risk committee expertise as a moderating variable, which could influence strategic decision-making regarding capital deployment. It focused on conventional stability indicators and ignored forward-looking measures or stress tests. Additionally, the study did not differentiate the effects of CAR across bank types or sizes. Despite these limitations, the study reinforces CAR's importance in preserving financial stability.



Theoretical Framework

This study is anchored on credit risk theory, which explains how banks manage the risk of borrower default and the implications of this risk for financial stability.

Credit Risk Theory: The foundational concept of credit risk management was formalized by Edward I. Altman in 1968, through the development of the Z-score model. Altman's model introduced quantitative measures for evaluating the likelihood of corporate default, thereby laying the groundwork for systematic credit risk assessment. This early work emphasized the importance of using financial ratios to predict potential insolvency and the need for proactive risk management strategies. The theory emphasizes that banks must identify and evaluate potential credit exposures, quantify potential losses, implement mitigation strategies such as collateral requirements and provisioning, and continuously monitor loan portfolios to ensure resilience against shocks (Nkusu, 2011; Louzis et al., 2012). Regulatory measures such as CAR and prudential provisioning policies are consistent with the theoretical principles, serving as essential tools for maintaining stability (CBN, 2024; Basel Committee on Banking Supervision, 2000).

Empirical studies in Nigeria have applied Credit Risk Theory to examine the relationships between credit risk indicators and bank stability. Chukwu (2024) applied the theory to analyze the effect of NPLs on financial stability, finding that higher NPL ratios reduce capital adequacy and increase vulnerability to shocks. Musa and Ajibola (2021) explored how prudential regulations and credit monitoring affect bank performance, showing that robust credit risk management enhances financial stability. Credit Risk Theory underpins this study by explaining the mechanisms through which banks manage credit risk and how these practices influence financial stability. By linking theoretical concepts with empirical measures such as NPLs, LLPs, and CAR, the theory offers a coherent framework for analyzing the effectiveness of credit risk management practices in sustaining the stability of Nigerian commercial banks.

Methodology

The study adopted an Ex-post facto research design. Ex-post facto research uses data already collected, but not necessarily amassed for research purposes. The population of the study is the thirteen (13) listed deposit money banks in Nigeria. The sampling technique was not employed neither was sampling procedures adopted in the selection of the sampled size due to the same



size of the population of study. The study used secondary source of data collection. The data were extracted from the annual reports and accounts of the sampled banks for a period of ten (10) years (2015 to 2024). The study used a panel regression technique based on the nature of the data used for analysis.

Results and Discussion of Findings

Table 2 presents the descriptive statistics of the variables over 130 observations. Financial Stability (FS) records a mean value of 10.88 with a standard deviation of 6.51, indicating moderate variability across banks and time. The low skewness (0.14) and kurtosis (1.96) suggest that FS is approximately normally distributed. Non-Performing Loans (NPL) show a mean of 8.67 but a very high maximum value of 110.39 and standard deviation of 15.23, indicating substantial dispersion and the presence of extreme values. The high positive skewness (3.96) and leptokurtic kurtosis (21.45) confirm that NPL is heavily right-skewed with outliers. Loan Loss Provisions (LLP) have a negative mean of -1.95 and moderate variability (Std. Dev. = 2.08), with negative skewness (-1.75) suggesting more observations clustered at higher values. Capital Adequacy Ratio (CAR) reports a mean of 12.47 but exhibits extreme dispersion (Std. Dev. = 23.50) and strong negative skewness (-4.37), implying the presence of unusually low capital positions in some cases. The high kurtosis values for NPL and CAR further indicate non-normality and potential outliers.

Table 3 presents the correlation matrix showing the relationships among Financial Stability (FS), Non-Performing Loans (NPL), Loan Loss Provisions (LLP), and Capital Adequacy Ratio (CAR). The correlation between FS and NPL is positive but very weak ($r = 0.0367$) and statistically insignificant ($p = 0.6781$), indicating no meaningful linear association between asset quality deterioration and financial stability within the sample. Similarly, FS and LLP exhibit a weak positive and insignificant relationship ($r = 0.0192$, $p = 0.8285$), suggesting that provisioning levels do not directly correspond with stability in a statistically significant manner.

However, NPL shows a significant negative relationship with LLP ($r = -0.3223$, $p = 0.0002$), implying that increases in non-performing loans are associated with changes in provisioning behavior, possibly reflecting adjustments in risk recognition or recovery dynamics. CAR is positively and significantly correlated with NPL ($r = 0.3056$, $p = 0.0004$), suggesting that banks with higher credit risk exposure may hold higher capital buffers, consistent with regulatory capital requirements. Meanwhile, CAR has a weak and insignificant negative relationship with FS ($r = -0.0014$, $p = 0.9878$) and with LLP ($r = -0.0536$, $p = 0.5449$).

Table 4 reports the results of the multicollinearity test using the Variance Inflation Factor (VIF). The centered VIF values for Non-Performing Loans (NPL), Loan Loss Provisions (LLP), and Capital Adequacy Ratio (CAR) are 1.23, 1.12, and 1.11 respectively. These values are substantially below the commonly accepted threshold of 10 (and even the more conservative threshold of 5), indicating the absence of serious multicollinearity among the explanatory variables. The low VIF values suggest that the independent variables are not highly correlated with one another and therefore do not distort the estimated regression coefficients. This implies that each variable contributes distinct information to the model in explaining



variations in financial stability. The tolerance levels (inverse of VIF) are also high, further confirming that collinearity is not a concern in the dataset.

Table 5 presents the results of the heteroskedasticity test with the null hypothesis of homoskedasticity (constant variance of residuals). The F-statistic of 3.0085 has a probability value of 0.3328, which is greater than the 0.05 significance level. Similarly, the Obs*R-squared statistic (8.6896) has a p-value of 0.3337, while the Scaled Explained Sum of Squares has a p-value of 0.2633. Since all probability values exceed 0.05, the null hypothesis of homoskedasticity cannot be rejected. This indicates that there is no evidence of heteroskedasticity in the model. In other words, the variance of the error terms is constant across observations. The absence of heteroskedasticity implies that the Ordinary Least Squares (OLS) estimates are efficient and that the standard errors, t-statistics, and probability values are reliable for hypothesis testing. Therefore, the regression results can be interpreted without concerns about biased standard errors arising from non-constant variance.

Table 6 presents the Hausman test results used to determine the appropriate panel estimation technique between the fixed effects and random effects models. The test reports a Chi-square statistic of 0.2907 with 3 degrees of freedom and a probability value of 0.0018. Since the p-value is less than the conventional 5% significance level, the null hypothesis that the random effects model is appropriate is rejected. This result implies that there is a systematic difference between the fixed and random effects estimators, suggesting that the individual cross-sectional effects are correlated with the explanatory variables. Consequently, the fixed effects model is preferred as it provides consistent and reliable estimates in the presence of such correlation.

Table 7 presents the fixed effects regression results on the determinants of financial stability (FS) of deposit money banks. The model shows strong explanatory power, with an R-squared of 0.982 and an adjusted R-squared of 0.980, indicating that approximately 98% of the variation in financial stability is explained by NPL, LLP, and CAR. The F-statistic (416.78, $p < 0.001$) confirms that the model is statistically significant. This high explanatory strength is consistent with recent empirical banking studies that show credit risk indicators and capital buffers jointly account for a substantial proportion of variations in bank stability (Akinlo & Emmanuel, 2022; Bishnu, 2019 updated empirical extensions cited in 2021–2023 studies).

Non-Performing Loans (NPL) have a negative and statistically significant effect on financial stability ($\beta = -0.0291$, $p = 0.0010$). This implies that increases in problem loans significantly reduce bank stability. The finding aligns with recent evidence that elevated NPL ratios weaken profitability, erode capital, and heighten insolvency risk in emerging banking systems (Ozili, 2020; Igbiosa & Naimo, 2020). Furthermore, the International Monetary Fund (2024) notes that rising credit risk remains a major vulnerability for banks in developing economies, particularly under conditions of inflationary and monetary tightening shocks. Similarly, the Central Bank of Nigeria (2024) emphasizes that asset quality deterioration is a primary threat to financial system resilience.

Loan Loss Provisions (LLP) show a negative but statistically insignificant relationship with financial stability ($\beta = -0.0018$, $p = 0.9673$). The insignificance suggests that provisioning levels, within the observed sample, do not independently determine stability outcomes. Recent Nigerian-focused studies argue that LLP may reflect regulatory compliance and forward-looking risk recognition rather than immediate financial weakness (Musa & Ajibola, 2021; Ene

& Bello, 2019, with subsequent 2021–2023 validations). Under evolving expected credit loss frameworks, provisions are designed to enhance resilience rather than destabilize banks, which may explain the absence of statistical significance.

Capital Adequacy Ratio (CAR) exerts a positive and statistically significant influence on financial stability ($\beta = 0.0124$, $p = 0.0095$), indicating that well-capitalized banks are more resilient. This result is consistent with post-2020 regulatory and empirical literature emphasizing capital buffers as shock absorbers. The Basel Committee on Banking Supervision (2021, reinforced in subsequent 2023–2024 updates) underscores that higher capital ratios enhance banks' capacity to withstand credit and market shocks. Empirical studies in emerging markets similarly confirm that strong capitalization improves solvency and reduces systemic risk exposure (Akinlo & Emmanuel, 2022; Adeleke & Yusuf, 2023).

Conclusion and Recommendations

This study examined the effect of credit risk management on the financial stability of quoted deposit money banks in Nigeria using Non-Performing Loans (NPL), Loan Loss Provisions (LLP), and Capital Adequacy Ratio (CAR) as explanatory variables. The findings revealed that non-performing loans have a negative and statistically significant effect on financial stability, implying that increases in bad loans weaken banks' resilience, profitability, and ability to sustain operations during periods of economic uncertainty. This confirms that poor asset quality remains a major threat to banking sector stability in Nigeria.

The study further found that loan loss provisions have a negative but statistically insignificant effect on financial stability. This suggests that although provisions are important risk management tools, their direct impact on stability may depend on the adequacy of provisioning frameworks, regulatory compliance, and the overall quality of banks' credit portfolios. In contrast, capital adequacy ratio was found to exert a positive and statistically significant effect on financial stability, indicating that banks with stronger capital buffers are better positioned to absorb unexpected losses and withstand financial shocks.

The study concludes that effective credit risk management is essential for sustaining the financial stability of quoted deposit money banks in Nigeria. The results demonstrate that controlling non-performing loans and maintaining adequate capital levels are critical

determinants of banking sector resilience. Therefore, strengthening credit risk governance, enhancing capital management practices, and improving loan monitoring mechanisms are necessary to promote long-term financial stability in the Nigerian banking industry.

Based on the findings, the study recommended that: Deposit money banks should enhance loan appraisal procedures, adopt data-driven credit scoring models, and intensify post-disbursement monitoring to reduce the incidence of non-performing loans.

Banks should maintain capital adequacy levels above regulatory minimum thresholds to absorb unexpected losses. Regulators should continue periodic stress testing to ensure capital resilience under adverse macroeconomic scenarios.

Banks should reduce excessive exposure to high-risk sectors by diversifying loan portfolios across industries to minimize concentration risk.

Although LLP was not statistically significant, banks should maintain prudent and forward-looking provisioning policies in line with expected credit loss frameworks to strengthen balance sheet transparency and investor confidence.

Supervisory authorities should implement enhanced early warning systems and macroprudential monitoring tools to detect rising credit risk trends before they threaten systemic stability.
