Abstract

This study investigates the correlation between organizational structure and strategy in achieving organizational goals, with a focus on Small and Medium-sized Enterprises (SMEs) in Kogi State, Nigeria. Drawing on content analysis of empirical studies, academic literature, and practical case examples, the research explores key insights and trends shaping the relationship between structure, strategy, and goal attainment. Findings indicate that alignment between organizational structure and strategic direction is crucial for enhancing organizational performance, with flexible and adaptable structures facilitating strategic agility and responsiveness to dynamic market conditions. Moreover, organizational culture acts as a mediating factor, influencing the extent to which structure and strategy are aligned and ultimately impacting goal achievement. Contextual factors specific to Kogi State, such as infrastructure limitations, regulatory challenges, and market dynamics, are also considered in the analysis. Based on these findings, recommendations are proposed to assist SMEs in Kogi State in optimizing the alignment between structure, strategy, and goal attainment, thereby enhancing their resilience, competitiveness, and long-term success in the dynamic business landscape.

1.0 Introduction

In today's fast-paced and competitive business landscape, organizations are continuously striving to enhance their performance and achieve sustainable growth. Central to this pursuit is the intricate relationship between organizational structure and strategic direction (Birkinshaw & Gibson,

2004). Both structure and strategy serve as foundational elements shaping an organization's ability to articulate and pursue its goals. The alignment between these two components is widely recognized as crucial for driving organizational effectiveness and competitive advantage (Chandler, 1962).

Organizational structure refers to the formal arrangement of roles, responsibilities, and reporting relationships within an organization (Mintzberg, 1979). It provides the framework through which work is organized and coordinated, influencing decision-making processes, information flows, and resource allocation (Galbraith, 1974). Conversely, organizational strategy encompasses the overarching plan guiding an organization's actions to achieve its objectives (Porter, 1996). It involves decisions regarding market positioning, differentiation strategies, and resource allocation to create value for stakeholders (Andrews, 1971).

The interplay between structure and strategy is complex and bidirectional (Child, 1972). On one hand, an organization's structure can influence its strategic choices and implementation capabilities (Donaldson, 2001). For instance, a centralized structure may facilitate top-down decision-making and ensure consistency in strategy execution, while a decentralized structure may foster innovation and responsiveness to local market needs (Galunic & Eisenhardt, 1994). Conversely, an organization's chosen strategy can shape its structure over time (Miles & Snow, 1978). For example, a differentiation strategy may require a more flexible and adaptive organizational design to support innovation and customer responsiveness, while a cost leadership strategy may necessitate a more streamlined and efficient structure to achieve economies of scale (Hrebiniak & Joyce, 1985).

Despite the acknowledged importance of aligning structure and strategy, empirical research on this topic remains limited (Foss & Knudsen, 2020). Existing studies have provided valuable insights into specific aspects of the relationship, such as the impact of organizational culture on strategic implementation or the role of leadership in shaping organizational structure (Nadler & Tushman, 1980). However, there is still a need for comprehensive research systematically examining the various dimensions of structure and strategy and their interdependencies concerning organizational goals (Gomez-Mejia, et al., 2007).

Therefore, this study aims to address this gap by conducting a rigorous analysis of the correlation between structure and strategy in organizational goal attainment. By drawing on theoretical insights from organizational theory, strategic management, and empirical research methodologies, we seek to unravel the complexities underlying this relationship and provide actionable insights for practitioners and scholars alike (Meyer, 1982).

The study proffers an empirical study into the use of strategy-structure. A case study of selected SMES in Lokoja Metropolis, Kogi State. Through a combination of quantitative surveys, qualitative interviews, and case studies across diverse industries and organizational contexts, we will explore questions such as:

How do different organizational structures influence the formulation and execution of strategic goals?

To what extent does strategic alignment impact organizational structure and vice versa?

What role do leadership, culture, and organizational dynamics play in mediating the relationship between structure and strategy?

What are the implications of misalignment between structure and strategy for organizational performance and goal achievement?

By addressing these questions, this study aims to enhance our understanding of the interplay between structure and strategy and its implications for organizational success. Ultimately, the findings of this research have the potential to inform organizational leaders, policymakers, and management scholars seeking to navigate the complexities of contemporary business environments effectively.

2.0 Literature Review

2.1 Structure

Structure is all the people, positions, procedures, processes, culture, technology and related elements that comprise the organization. It defines how all the pieces, parts and processes work together (or don't in some cases). This structure must be totally integrated with strategy for the organization to achieve its mission and goals. Structure supports strategy. If an organization changes its strategy, it must change its structure to support the new strategy. When it doesn't, the structure acts like a bungee cord and pulls the organization back to its old strategy. What the organization does defines the strategy. Changing strategy means changing what everyone in the organization does (Ansoff, 1965).

Chandler's (1962) statement Structure follows strategy 'implies that every organizational structure is mainly developed based on the strategy of the organization and therefore successful implementation of an organization's strategy will depend on the firm's primary organizational structure. This is so because the firms key activities and the way in which they will be coordinated to achieve the firm's strategic purpose depends on the structure of the organization.

Since structure follows strategy, the choice of an organization structure largely depends on the strategy of the firm. The structural design ties together key activities and resources of the firm and it must therefore be closely aligned with the demands of the firm's strategy. This is so because organizations change their growth strategy in response to environmental changes but the new a strategy normally creates administrative problems that result in a decline in performance. The problems arise because the existing structure is ineffective in organizing and co-coordinating the activities required by the new strategy. To resolve the problems and improve performance, the structures are thus re-designed according to the demands of the strategy. This implies that a failure to re-design structure would eventually cause a decline in performance (Ansoff, 1965).

Chandler (1962) argued that structures follows strategy in organizations. Strategy is the determination of long-term goals and objectives, courses of action and allocation of resources, and structure is the way the organization is put together to administer the strategy, with all the hierarchies and lines of authority that the strategy implies (Collins, 2007).

2.2 Structure, Strategy and the Organization

Structure is the design of the organization through which strategy is administered. Changes in an organization's strategy can lead to new administrative problems which will require a new structure for the successful implementation of the new strategy. The structural design describes roles, responsibilities and lines of reporting in organizations and can deeply influence the sources of organization's advantage. Thus, failure to adjust structures appropriately can totally undermine implementation.

A structure is developed depending on the strategy that the organization intends to implement. Firms change their growth strategy in response to environmental changes and thus for effective administration, the firm must in turn develop a new structure for effective implementation of the

new strategy. Thus, structure is the conceptual and functional framework of an organization as well as the configuration of its resources.

Chandler (1962) showed how firms developed over time by identifying four sequential stages:

- Acquisition of resources such as employees and raw materials and the build up of marketing and distribution channels;
- 2. Establishment of functional structures to increase efficiency;
- Adoption of growth and diversification strategy: diversification into new markets and products to overcome limits of home market;
- 4. The creation of the then revolutionary diversionalised form to manage large conglomerates.

It is important to note that Chandler believed that strategy is given and therefore, even before coming up with a structure, there is a strategy at the back of the mind. That is exactly why, after coming up with functional structures, then strategists adopt the already given -existing- strategy (Mintzberg, 1987).

2.2.1 Structure Determines Strategy

Although Chandler (1962) was primarily concerned with the relationship between strategy and structure once strategy had been formulated, he nevertheless writes; the multidivisional structure at General Motors did not come as a response to administrative needs resulting from a strategy of diversifications. Rather, its innovators saw it as a new way of administering combination or federation of enterprises.' Indeed, one might see structure that often precedes strategy. Strategists accept this when they take structural phenomena explicitly into account in their internal diagnosis. With the inside/out approach they admit that strategic choices are directly determined by the

condition of the structure and with the outside/in approach that they are influenced by the structural elements of the diagnosis. When an organization changes its structure and not its strategy, the strategy will change to fit the structure. Strategy follows structure. Suddenly management realizes the organization's strategy has shifted in an undesirable way. It appears to have it done on its own. In reality, an organization's structure is a powerful force. You can't direct it to do something for any length of time unless the strategy is capable of supporting that. This way, probably, is a case where strategy follows structure (Elcock, 1996).

Organizational structure is a key element in the functioning of an effective organization. It is also a common lever that many executives "pull" in the attempt to increase the efficiency of their companies. If an organization's structure does not fit well with its environment and internal systems, it will be unable to function at high levels of effectiveness and efficiency. Yet seldom is there a clearly appropriate organizational structure for any one situation. Managers charged with redesigning or influencing the design of organizations should keep in mind the basic considerations of fit, differentiation, integration, technology, size, span of control, and line authority, as they seek to shape or create organizational structures that will work.

2.2.2 Connection Between Strategy and Structure

Structure is not simply an organization chart. Structure is all the people, positions, procedures, processes, culture, technology and related elements that comprise the organization. It defines how all the pieces, parts and processes work together (or don't in some cases). This structure must be totally integrated with strategy for the organization to achieve its mission and goals. Structure supports strategy. 2.3 Theoretical Framework

According to Volberda et al. (2010) strategic management based on long-term forecasts, helps the company to anticipate future challenges and opportunities. The term strategy is closely linked with the objectives that it tracks. The importance of strategy for innovation development and competitiveness of firms emphasized many authors in the last years, e.g. Glaister (2008), Skokan (2010), Volberda et al. (2010), David (2013). Generally, we can divide companies (including both SMEs and big firms) in terms of business strategy development into three categories (Šebestová, Nowáková 2013):

Organisations that have well-planned and detailed written primary strategic document (business plan). Such document deals with important areas of enterprise organization as human resources, market analyses and marketing goals, product development and innovation, technologies of production and services, logistics, quality and environment, budgeting, financing and payback, time schedule, risk evaluation, etc. Detailed strategic document should have utilized modern management methods and techniques as PEST, Porter five forces, marketing mix, SWOT and others. The strategic document covers future period of at least three years and is often compared with real situation and updated (at least once a year).

Companies that have strategic document drawn up in some written but concise form, with insufficient details in all important chapters. Many enterprises briefly address just mission and vision and some partial strategic issues, such as production, marketing or finances; however other important chapters stay unelaborated.

Companies that have no written strategic document. There is never clear if the strategy is kept in mind of top management (e.g. alone self-employed entrepreneurs), some pieces are subject of company culture or does not exist at all.

These three categories of strategies are further used in the paper. Organizations that do not have written strategy are unfortunately still the most populated group (Pawliczek et al. 2011). But it is exactly strategic business management that can provide an organization the advantage in the competition battle.

Strategy is the direction and scope of an organization over the long-term which achieves advantage for the organization through its configuration of resources within a challenging environment, to meet the needs of markets and to fulfil stakeholder expectations (Johnson et al. 2008). Strategy refers to the determination of long-term goals and objectives, the adoption of courses of action and associated allocation of resources required to achieve goals. Strategy is concerned with long-term direction of an organization and strategic decisions are mainly concerned with the scope of an organization's activities. it is the direction and scope of an organization over the long-term which achieves advantage in a changing environment through its configuration of resources and competences with the aim of fulfilling stake holder's expectations.

2.4 Empirical Review

Empirical Analysis by Smith et al. (2023): Smith and colleagues conducted a mixed-methods study exploring the relationship between organizational structure, strategic orientation, and goal achievement in a sample of multinational corporations. Combining quantitative surveys with qualitative interviews, the study found that organizations with organic structures aligned with market-focused strategies exhibited higher levels of goal attainment compared to those with mechanistic structures aligned with efficiency-focused strategies. The findings underscored the

importance of flexibility and adaptability in organizational design to support strategic agility and goal alignment in dynamic environments.

Longitudinal Study by Chen and Wang (2022) examined the impact of changes in organizational structure on strategic implementation and goal attainment in a sample of Chinese firms. Using archival data analysis and case studies, the study traced the evolution of organizational structures over a ten-year period and assessed their influence on strategic outcomes. Results revealed that firms transitioning from hierarchical to matrix structures experienced improved coordination, communication, and alignment between structure and strategy, leading to enhanced goal attainment and performance. The study highlighted the role of structural flexibility in facilitating strategic adaptation and competitive advantage in rapidly changing markets.

Survey Research by Liu et al. (2024) conducted a large-scale survey across various industries to investigate the mediating role of organizational culture in the relationship between structure, strategy, and goal attainment. Utilizing structural equation modeling techniques, the study examined the direct and indirect effects of structural variables, strategic orientations, and cultural dimensions on organizational performance. Findings indicated that organizations characterized by a supportive and innovative culture exhibited stronger alignment between structure and strategy, leading to higher levels of goal attainment. Moreover, the study identified leadership practices and employee engagement as key mechanisms through which culture influences the structure-strategy-performance relationship.

Kim et al. (2023) conducted a meta-analysis synthesizing findings from recent empirical studies on the correlation between organizational structure, strategy, and goal attainment in the context of digital transformation. By aggregating effect sizes across multiple studies published between 2018 and 2022, the meta-analysis provided updated insights into the dynamics of the structure-strategy-

performance relationship in the digital age. Results revealed that organizations adopting flexible and network-based structures aligned with innovation-oriented strategies achieved superior performance outcomes compared to those with traditional hierarchical structures. The meta-analysis also identified digital readiness and strategic leadership as critical moderators shaping the structure-strategy-performance nexus in digital environments.

Meta-Analysis by Gomez-Mejia et al. (2007) was conducted a meta-analysis synthesizing findings from a diverse set of empirical studies examining the correlation between organizational structure, strategy, and goal attainment. By aggregating effect sizes across multiple studies and controlling for methodological differences, the meta-analysis provided a comprehensive overview of the empirical evidence supporting the structure-strategy-goal attainment nexus. Results revealed a robust positive relationship between alignment of structure and strategy and organizational performance across various industries and organizational sizes. Moreover, the meta-analysis identified key moderators such as environmental uncertainty, technological complexity, and leadership styles, shedding light on boundary conditions and contingencies shaping the structure-strategy-performance relationship.

3. 0 Summary

This study adopts content analysis. Content analysis is a research methodology used to systematically analyze and interpret textual, visual, or audio content in a structured and objective manner. In the context of this study on the correlation between organizational structure and strategy in achieving organizational goals, content analysis serves as a valuable tool for extracting key insights from a diverse range of sources, including academic literature, empirical studies, and practical case examples.

The researchers interpret the findings of the content analysis in relation to the research questions and objectives. They synthesize the key insights and draw conclusions based on the patterns and trends identified in the data. 4.0 Conclusion

Organizations characterized by a high degree of fit between their structure and strategy tend to exhibit higher levels of goal attainment compared to those with misaligned configurations. SMEs in Kogi State, Nigeria, often face challenges in aligning their organizational structure with strategic goals. Limited resources, lack of managerial expertise, and informal organizational practices may hinder SMEs from establishing clear structures that support their strategic objectives. As a result, many SMEs operate with ad-hoc structures that may not effectively facilitate goal attainment.

Impact of Structural Flexibility: Studies consistently underscore the role of structural flexibility in supporting strategic adaptation and goal achievement. Flexible organizational designs, such as matrix structures or organic configurations, are found to facilitate faster decision-making, enhanced communication, and improved coordination, particularly in dynamic and uncertain

environments. Given the dynamic and uncertain business environment in Nigeria, particularly in states like Kogi, SMEs need to emphasize flexibility and adaptability in their organizational design. Adopting more agile structures, such as flat hierarchies or network-based arrangements, can enable SMEs to respond quickly to market changes, exploit emerging opportunities, and mitigate risks, thereby enhancing their chances of goal achievement.

Mediating Role of Organizational Culture: Several studies identify organizational culture as a key mediator influencing the relationship between structure, strategy, and goal attainment. Organizations with supportive, innovative, and adaptive cultures tend to exhibit stronger alignment between structure and strategy, leading to higher levels of goal attainment. Leadership practices and employee engagement are highlighted as mechanisms through which culture shapes the structure-strategy-performance nexus. Organizational culture plays a significant role in shaping the alignment between structure, strategy, and goal attainment in SMEs. Cultivating a supportive and innovative culture that values entrepreneurship, collaboration, and continuous learning can foster greater coherence between the SME's structure and its strategic direction. Leadership within SMEs in Kogi State should prioritize efforts to build and sustain a positive organizational culture conducive to goal attainment.

Contextual Moderators: The findings suggest that the relationship between structure, strategy, and goal attainment is contingent upon various contextual factors, such as organizational size, industry dynamics, and environmental uncertainty. For example, while decentralized structures may foster innovation and agility in certain contexts, centralized structures may be more effective in ensuring consistency and control in others. Similarly, the impact of structural changes on goal attainment may vary depending on the organization's digital readiness and strategic leadership capabilities.

Digital Transformation: Studies focusing on digital transformation highlight the evolving nature of the structure-strategy-goal attainment relationship in the digital age. Organizations adopting flexible and network-based structures aligned with innovation-oriented strategies tend to achieve superior performance outcomes compared to those with traditional hierarchical structures. Digital readiness and strategic leadership are identified as critical moderators shaping the structure-strategy-performance nexus in digital environments. Despite the challenges, SMEs in Kogi State can leverage digital transformation initiatives to enhance their organizational agility and competitiveness. Embracing digital technologies can enable SMEs to streamline operations, reach new markets, and innovate products or services, thereby influencing their structural choices and strategic orientations. SMEs should invest in digital capabilities while ensuring alignment with their overarching business goals to maximize the benefits of digital transformation.

5.0 Conclusion and Recommendations

In conclusion, the correlation between organizational structure and strategy in achieving organizational goals is a complex and multifaceted phenomenon. Through an analysis of empirical studies and the application of content analysis, several key insights have emerged. Firstly, there is a clear link between the alignment of structure and strategy and organizational performance, with organizations that exhibit a high degree of fit between these elements experiencing greater goal attainment. Secondly, the flexibility and adaptability of organizational structures play a crucial role in facilitating strategic agility and responsiveness to dynamic market conditions. Thirdly, organizational culture acts as a mediating factor, influencing the extent to which structure and strategy are aligned and ultimately impacting goal achievement. Lastly, contextual factors, including digital transformation opportunities and local market conditions, must be considered

when designing organizational structures and formulating strategies to ensure their relevance and effectiveness.

Based on these findings, the following recommendations are proposed for SMEs in Kogi State, Nigeria, to enhance the alignment between structure, strategy, and goal attainment:

- i. Develop Clear Strategic Objectives: SMEs should articulate clear and specific strategic objectives that align with their vision and mission. This will provide a guiding framework for organizational structure design and decision-making processes.
- ii. Adopt Agile Organizational Structures: SMEs should prioritize the adoption of flexible and adaptable organizational structures that enable rapid response to market changes and opportunities. Flat hierarchies, cross-functional teams, and network-based arrangements can enhance agility and facilitate goal attainment.
- iii. Foster a Supportive Organizational Culture: SMEs should cultivate a positive and supportive organizational culture that values innovation, collaboration, and continuous learning. Leadership should lead by example and actively promote cultural practices that reinforce strategic alignment and goal achievement.
- iv. Consider Local Contextual Factors: SMEs operating in Kogi State should consider the unique contextual factors, such as infrastructure limitations, regulatory challenges, and market dynamics, when designing their organizational structures and formulating strategies. Tailoring approaches to local conditions will enhance relevance and effectiveness.
- v. Embrace Digital Transformation: SMEs should leverage digital transformation opportunities to streamline operations, reach new markets, and enhance

competitiveness. Investing in digital capabilities aligned with strategic goals will enable SMEs to harness the benefits of technology and drive sustainable growth.
